RELEASE AND INDEMNIFICATION TO USE AIRSTRIP

VOLUNTARY PARTICIPATION

I acknowledge that I intend to voluntarily use the 5,200 foot paved rural landing strip, approximately 4,700 asl, located on the Red Reflet Ranch ("the airstrip") and that I am aware of the hazards associated with the airstrip and activities I may participate in when using the airstrip and by signing this document, I intend to release Red Reflet Ranch, its employees, agents and owners for any liability related to my use of the airstrip.

ACKNOWLEDGEMENT AND ASSUMPTION OF RISKS

I am aware that use of the airstrip involves hazardous activities in remote areas with the risk of accident, injury or death which may be caused by forces of nature, by my own acts or the acts of other visitors, or by the negligence of Red Reflet Ranch and each of its employees, owners, officers, directors, or other agencies known or unknown (the "Released Parties"). In order to use the airstrip, I am willing to assume all risks and uncertainty involved, including but not limited to risks associated with physical condition of the airstrip, weather, wild animals, domestic stock, smoke from forest fires, natural and man made obstacles, and other natural and man-made hazards. I am also aware that medical services or facilities are readily available during my use of the airstrip and, nonetheless, agree to use the airstrip and engage in activities during my use of the airstrip in spite of the hazards and the absence of medical assistance.

I hereby accept and assume full responsibility for any and all risks of illness, injury or death connected or in any way related to my use of the airstrip, whether due to the conduct of myself, other participants or the negligence (other than willful or wanton misconduct) of the Released Parties>

RURAL AIRSTRIPS

I understand that there are particular risks associated with the used of rural airstrips. I acknowledge that the use of such airstrips involves a risk of physical injury to any individual undertaking such activities.

RELEASE AND COVENANT NOT TO SUE

In consideration of receiving permission from RED REFLET RANCH to enter the premises and use the airstrip on the Ranch, I hereby agree that neither I, nor any heirs,

assigns, agents, personal or legal representatives, or family members will bring suit or make a claim for illness, injury or death resulting from acts, conditions or events described in the preceding paragraphs. I hereby release and agree to indemnify RED REFLET RANCH and each of its owners, officers, directors, or other agencies known or unknown from and against any and all liability arising out of, or in any way connected with, my used of the airstrip, including any liability for negligence (other than willful or wanton misconduct).

INDEMNIFICATION

By executing this agreement, either for myself or for any minor under the age of 18, I hereby agree to indemnify and hold harmless RED REFLET RANCH and all the Released Parties from any and all claims, costs and attorney’s fees incurred by the Released parties, as a result of any claim or action brought by myself, the minor, any passenger in the aircraft, or brought on behalf of any passenger, myself or the minor against the Released Parties.

Pilot-In-Command

*As the **Pilot-In-Command**, I hereby warrant and represent that I have read the foregoing document and that I have furnished a copy of each passenger and have discussed it with my passengers or, if such passenger is a minor, then with his/her parent or guardian; and I have obtained the signature of each passenger of my aircraft, or his/her parent or guardian, to this Release and Indemnification To Use Airstrip.*
